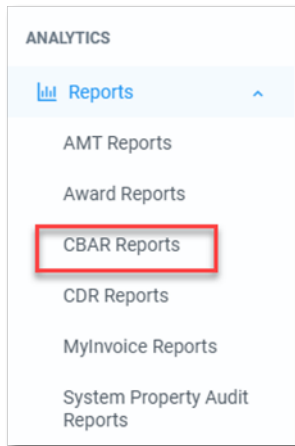

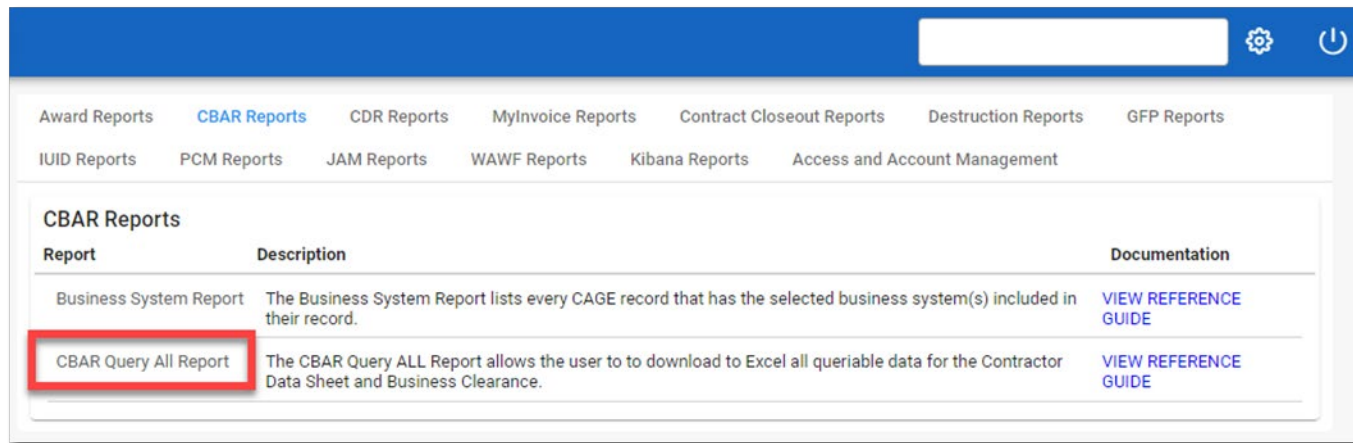

## Where to Run the Report

Expand the **Reports** menu under Analytics in EDA and select the **CBAR Reports** option.



In the CBAR Reports section select the **CBAR Query All Report**.



Enter the search criteria on the **Query Details/Search Query** page.


