Access the SF30	<p>The View PDF button on a MDO Modification or ARZ Modification downloads and opens a Standard Form 30 (SF30) PDF of the ARZ Modification / Modification during the workflow. The SF30 provides the ARZ Modification / Modification information for the modified Contracts/Orders.</p> <p>How to Access the SF30</p> <ol style="list-style-type: none"> 1. Log in to Procurement Integrated Enterprise Environment (PIEE) Application (https://piee.eb.mil/). 2. Open the Modifications and Delivery Orders (MDO) by clicking the 'MDO' icon. 3. Select Search under the MDO navigation section or use the document tables on the Dashboard. 4. Enter Search Criteria and click the Search button. 5. Search Results display below the Search Criteria and allow new searches without leaving the page. 6. Find the ARZ Modification or Modification and click the Document ID number hyperlink to open the document. 7. Review the document information to ensure it is the correct document. 8. Click the View PDF button, a PDF downloads to the local machine. 9. Open the PDF to view the SF30. <p><i>NOTE: Viewing an SF30 during the workflow with multiple Contracts/Orders selected only displays the information of one Contract/Order. The individual Contracts/Orders are on the SF30 after the ARZ Modification / Modification is released.</i></p>
